## **Training Contract**

### Training Contract

This agreement is between Canebrake Retrievers, LLC and client for training the client's dog for gun dog training and/or basic obedience.

Outlined below are the standard terms applicable to this agreement:

#### HEALTH

A) Vaccinations: Client agrees to vaccinate or have vaccinated his/her dog for the following canine diseases before placement in the training program. Proof of the vaccination requirement via veterinary documentation is mandatory to this agreement and required before or on the day you drop your dog off for training.

1) DA2PPV-L (Canine Distemper, Hepatitis, Canine Adenovirus Type 2, Parvovirus, Parainfluenza, Leptospirosis)

2) Bordetella

3) Rabies

B) Preventative Medication:

1) Client agrees to provide monthly heartworm preventative medication.

2) Client agrees to provide monthly flea, tick, and mosquito preventative medication.

C) Emergency: Client agrees to cover all expenses related to emergency and/or routine veterinary visits required for client's dog while under the care of Canebrake Retrievers, LLC. The client further authorizes Canebrake Retrievers, LLC to seek veterinary assistance as needed in emergency situations.

#### TRAINING FEES

A) The monthly gun-dog training fee is \$700 per month. First month's training fee is due the day you drop your dog off. NOTE: Reservation deposits will be applied towards the first month's training fee.

B) There is a 4-month minimum for all dogs in the Gun Dog Training Program that have not completed the "Basic Program" with Canebrake Retrievers.

C) The basic obedience training program (available to all large breed dogs) is a 6-week program and the fee is \$1,000. First month's training fee is due the day you drop your dog off. NOTE: Reservation deposits will be applied towards the first month's training fee.

D) Client understands and agrees that training fees are on a "per month" basis. This means that while client's dog is in training the client will be billed for the training month in its entirety regardless if the dog is taken home for periods of time for whatever reason (except medical reasons). If client wishes to remove his/her dog from the training program the removal must be done prior to the start of another training month.

E) Fees are due no later than the beginning of each "Training Month" (every 4 weeks). Canebrake Retrievers, LLC agrees to make the best effort to train the dog to work toward these goals. Canebrake Retrievers, LLC will evaluate the dog and assess strengths and weaknesses as training progresses. Not every dog is cut out for every job, Jason Daves and client both understand this. Canebrake Retrievers, LLC agrees to keep client informed of any issues/concerns that arise which might prevent this dog in

achieving these goals so that together, Canebrake Retrievers, LLC and client can decide the right path to follow for the dog's continued training period.
